Ahead of January 1, 2022 PostNord is introducing a reservation that allows it to apply a percentage-based surcharge to the services below. The reason for this reservation is a recently introduced EU Directive known as the Mobility Package that aims to improve working conditions for drivers, which may entail increased costs for hauliers/transport. PostNord starts adding an extra surcharge to Road Transport within Europe services with effect from 1 February 2022.

The services concerned and current surcharges are shown in the table below.

PostNord applies the Mobility Package surcharge condition, included in the General Terms and Conditions (PAKN) of the PostNord agreement, to the following services.

The Mobility Package surcharge is calculated as a percentage of the freight cost for pallets, groupage cargo (Nordic region), part loads (Sweden), part loads and groupage cargo (Europe), and InNight, both domestic and international, excluding any additional services.

The surcharge is presented separately on the invoice.

The percentage is set each month.
